Facilities User Agreement for Non-Church Affiliated Groups

PURPOSE: This Agreement gives permission to groups, organizations, and individuals ("User") not directly overseen by Fern Creek United Methodist Church, to use specified facilities owned by Fern Creek United Methodist Church. Users of the facilities, with the permission of Fern Creek United Methodist Church, do so with the full knowledge that losses or liabilities incurred by the User are not covered by the local church.

WHEREAS Fern Creek United Methodist Church is the owner of the facilities/premises located at the address printed above; AND WHEREAS the User desires to use said facilities on the terms and conditions set forth. NOW, THEREFORE, in consideration of the mutual promises contained herein and other good valuable consideration the parties agree as follows:

1. Fern Creek United Methodist Church will make available to the User: _____

3. User agrees to indemnify and hold Fern Creek United Methodist Church harmless from any and all liability including attorney's fees arising out of User's use of the above premises or the building of which the facilities are a part, or the parking facilities on or adjacent thereto.
4. The User understands that the responsibility to obtain liability and property insurance is upon the User. It is not the duty or responsibility of Fern Creek United Methodist Church to insure the User's use of the facilities. It is recommended that the User obtain its own liability and property coverage for its use of the facilities.
5. The User agrees to abide by and obey all laws, ordinances, and regulations promulgated by any government unit having jurisdiction in the locale of Fern Creek United Methodist Church, and will not engage in any activities in violation of such laws, ordinances, rules, and regulations.
6. If any of the User's activities at Fern Creek United Methodist Church will place children or youth under the age of 18 by persons in the care of persons other than their own parents or guardians, the Users must either: (a) comply with Fern Creek United Methodist Church's Safe Sanctuaries Policy for the prevention of child abuse, or (b) supply a copy of its own child abuse prevention policy which is substantially similar in practice and effect to Fern Creek United Methodist Church's Safe Sanctuaries Policy, and certify compliance by signing below.
